

# ELEMENTARY PEAKE After-School Program

Dear Parents,

Sadly, we found out this summer that Chesapeake Elementary did NOT receive a 21<sup>st</sup> Century Grant to have an after school program. However, our school board, along with the Gallia-Vinton Educational Services Center, pooled their resources to give us some funds to have the program after all! We are so grateful for their help to keep this program running for our community. The program will still be free of charge to you. However, we will not be able to have special nightly family events this year. Attached you will find an application to our PEAKE After-School Program. **Since we are behind schedule due to COVID restrictions, we will need to do the applications in person this year. We will post this application online so that you may print it and fill it out—or we can give you a paper copy when you come to one of the sign up days. THE THREE IN-PERSON SIGN UP DAYS ARE THURSDAY, OCT. 1<sup>st</sup> (3-5pm), FRIDAY, OCT. 2<sup>nd</sup> (5-7pm), and SATURDAY, OCTOBER 3<sup>rd</sup> (12-1pm). You will be notified by October 9<sup>th</sup> if your child has received one of the available spots.** Priority will be given to students who have academic need, have had good attendance in the program in the past, and have had good behavior in the program in the past.

The program will begin VIRTUALLY MONDAY, October 12, 2020 using Google Meets to help with homework. **The program will begin IN PERSON on Monday, October 19<sup>th</sup>** and will be available **Monday, Tuesday, Thursday, and Friday after school until 5:00 p.m. (WHEN THE SCHOOL WEEK GETS BACK TO NORMAL, WE WILL GO BACK TO STAYING MONDAY-THURSDAY.)** The final day of the program is tentatively April 22, 2021. Our school still offers the pay Day care, which is available every day until 5:30, including Fridays. School board funds will pay for the PEAKE program and day care parents will continue to pay current rates for the pay Day Care Program. If your child does not receive one of the PEAKE spots and you are interested in the pay day care, please let us know and we will have a day care staff member contact you promptly.

Here is an idea of the daily schedule: Students will have a short break to use the restroom & enjoy a short play time following school in a socially distanced way, and then will be offered intervention and homework help from 3:00-3:55. This does not mean that 100% of your child's homework is guaranteed to be completed, but we'll do our best! Following tutoring and homework time, students are all provided a snack and either juice or milk. From 4:05-4:55 students will take part in fun activities while still staying with a small core group of students to help with continued social distancing. Masks will be worn, just like during the school day. The program ends at 5pm. Your child can ride a bus if you provide the appropriate information on the application, or you may pick them up.

**DEADLINE TO TURN IN APPLICATIONS IS SATURDAY, October 3, 2020.** We will be located outside the elementary school from 3-5pm on Thursday, October 1<sup>st</sup>, from 5-7pm on Friday, October 2<sup>nd</sup>, and from 12-1pm on Saturday, October 3<sup>rd</sup>. You must come in person one of those days to turn your forms in due to time constraints this year. Please remember, students must attend regularly to remain enrolled in the program.

**PLEASE READ THIS CAREFULLY: There are 13 buses that run after REGULAR school but ONLY 4 that run after PEAKE. The routes are ALL redone according to where the kids IN the program each year live. If you want your child to ride a PEAKE bus we have to know NOW while we're making the routes. We also have to have specific directions to your house and describe your house (as if you are having a pizza delivered. CHOOSE Bus OR Pick Up, but not both! 😊**
