

# Chesapeake Schools Laptop Policy

The mission of the 1:1 device program at Chesapeake Union Exempted Village School district is to create a collaborative learning environment, through the utilization of meaningful and adaptive technology. This program will enrich the education and academic process for all students in our district. This program will promote content engagement and enhance student/teacher collaboration. It will allow teachers and students the ability to grow and transform their curriculum using effective delivery tools.

## Devices

Chesapeake Union Exempted Village School District is supplying students in grades Kindergarten through 12<sup>th</sup> grade with a laptop. This device will be the property of the district. This device will provide each student access to educational materials needed for instruction during the school year. This laptop will allow students the ability to access all relevant technologies that will be utilized both for present and remote learning.

## Ownership

The laptop is considered district property while the student is enrolled at Chesapeake Union Exempted Village School District. Students will be assigned a laptop with an asset tag that will be recorded by the technology staff as well as by board administration. This asset tag shall always remain on the device and should never be removed/modified/tampered.

## Important Information (Management/Filtering/Use/Damage)

- Proper care and handling should always be practiced. Students will be responsible for the care of their device.
- Students will be responsible for keeping their charger in good working order and keeping their device charged for use at school.
- **Web Filtering** – Chesapeake Union Exempted Village School District maintains CIPA (Children's Internet Protection Act) compliance both at school and at home. Each laptop will have web filtering technology enabled. In no way should students attempt to remove, subvert, modify, or bypass this filtering measure. *Please note that doing so is within violation of this acceptable use policy and will result in administrative action or removal of this device.*
- **Modification/Alterations** – Students shall not modify or alter their issued laptop. This includes paint, stickers, markers, or personalization items. At no point should a student modify the laptop from its original, out-of-the-box, appearance. Students shall not modify or alter the operating system. This includes non-

educational programs, backgrounds/wallpapers, or malicious programs. ***Please note that doing so is within violation of this acceptable use policy and will result in administrative action or removal of this device.***

- Students and parents are encouraged to discuss and practice safe and educational device use. Students should not use their school email address for personal purposes. Students should refrain from unhealthy online practices as outlined in the School's acceptable use policy.
- **Damage** – In the event of accidental damage the student is to report that to their teacher/principal or directly to the technology director immediately. ***Please note that habitual/chronic/malicious damage could result in administrative action or removal of the device.***
- **Theft/Loss** – In the event that a device is lost or stolen the student is required to report that to the teacher/principal or directly to the technology director immediately so that proper actions and reporting can proceed.

### **Student Agreement**

I have read, understand, and agree to abide by Chesapeake Union Exempted Village School District's laptop Policy and Procedure. Should I commit any violation or in any way misuse my laptop, I understand and agree that my laptop may be revoked, and disciplinary action may be taken against me. If I am under the age of 18, I understand that when I turn 18, this agreement will continue to be in effect, and I agree to abide by this agreement.

### **Parent Agreement**

As the parent or legal guardian of the above minor, I have read, understand, and agree that my child shall comply with the terms of the Chesapeake Union Exempted Village School District's laptop Policy. I understand that the laptop is a privilege and can be revoked if misused. I am signing this Policy and agree to indemnify and hold harmless the School, and the School District that provided this laptop to my child, against all claims, damages, losses and costs, of whatever kind, that may result from my child's use of his or her laptop or violation of the foregoing Policies and Procedures. Further, I accept full responsibility for supervision of my child's use of his or her laptop when such access is not occurring during the school day. I hereby give permission for my child to use a laptop authorized by Chesapeake Union Exempted Village School District.
