## \*FAFSA INFORMATION: (FREE APPLICATION FOR FEDERAL STUDENT AID)

The FAFSA must be completed electronically for 2021-2022 college freshmen to be considered for federal and state student grants, work-study programs, and loans. Many scholarship programs also require that the FAFSA be completed before considering students. Log in at <a href="https://fsaid.ed.gov">https://fsaid.ed.gov</a> to obtain FSA ID numbers for both the student and one parent. To complete the FAFSA, go to <a href="https://swww.fafsa.gov">www.fafsa.gov</a> PLEASE COMPLETE THE FAFSA BEGINNING OCTOBER 1. Most colleges have moved scholarship deadlines up to January or even earlier because of the FAFSA now being completed earlier!

When your son/daughter starts receiving financial package letters from colleges, please pay close attention to the following and know the difference between the types of loans for which they may qualify:

\*Direct Subsidized and Unsubsidized Loans are two separate, unique types of loans that are awarded separately: Please know the difference before accepting any loans:

"Subsidized Loans" - need based; no interest is charged while the student is in school.

"Unsubsidized Loans"- not need based; interest is charged from the time the student receives the loan.

If you are a senior that is attending Collins Career Center, you have an e-mail set up by Collins. Any reminders of events, pictures, or things you should be aware of at CHS will be sent to you via e-mail. It is your responsibility to check your e-mail to know what is going on at your home school. If you are a CCP student or attend outside the high school building, it is your responsibility to check with the high school office to keep updated on events. It is not possible for us to contact each of you individually!

<u>College Representatives</u>: Once students return in person, we will try to set up as many virtual meetings with colleges as possible. Until that time, students are encouraged to contact the admissions office at colleges in which they are interested, to see if it is possible to take virtual one on one tours or have virtual one on one meetings.

<u>CHS Yearbook Senior Pages</u>: Pages are available for parents to congratulate 2021 graduates. There are a limited number of pages available and they will be sold on a first come-first serve basis. Prices are \$50 for half page and \$100 for a full page. <u>ACT Dates:</u> December 12 (Registration deadline Nov 6)

February 6 (Registration deadline Jan 9)

Cost is \$55.00. Special note: The ACT Assessment Plus Writing may be required by some colleges and universities. The cost of the Plus Writing version is \$70.00. Students need only take the Plus Writing version once. (STUDENTS MUST UPLOAD A PICTURE TO THEIR ACT ACCOUNT. STUDENTS NEEDING TO UPLOAD THE PICTURE CAN SEE MRS.DAY FOR ASSISTANCE)

<u>Marshall University ACT:</u> The Walk-In ACT is given each month; scores are <u>only</u> good for MU. For more information, go to: <u>www.marshall.edu</u> (student resource center link)

<u>ACT & SAT Prep Classes:</u> Marshall University and Ohio University Southern Campus offer ACT/SAT Prep Classes throughout the year. If interested, students should listen for announcements or call MU at 304-696-6855 or OUSC at 533-4600.

<u>ACT Fee Waivers:</u> Juniors and seniors who meet the economic need indicators (free lunch) are eligible to use an ACT fee waiver to cover the cost of the test (basic ACT only). Students may take the test two times using a fee waiver form. If a student feels they qualify for the waiver, they should see Mrs. Day for details and the form.

<u>College Visits:</u> Each senior is permitted to take 3 excused days to visit a college or other educational institution. A completed College Day form (with parent and teacher signatures) <u>must</u> be submitted to the guidance office at least two days before the scheduled visit. Students must schedule the visit with the college in advance. Upon returning to school, students must present to the guidance office a signed form from the college visited. <u>In order to be excused for the day, the above procedure must be followed.</u> No excused college visits will be permitted during the month of May.

<u>Scholarships</u>: Scholarships of which the guidance office receives information will be announced in this monthly newsletter but please understand that there are thousands of scholarships available which can be found on-line and through other sources. Students should not wait until the day they need to send the application to ask for the transcript. <u>Society of Yeager Scholars</u>: Deadline is December 15. (Application will be available on-line after Oct 1). Yeager is Marshall University's 4 year full scholarship. Minimum requirement for consideration is a composite of 30 on the ACT or 1340 on the SAT. A lengthy application is required. Please see MU's website for more info.

NFIB Young Entrepreneur Award Program: Can apply October 1 - December 18. To qualify, student must have demonstrated entrepreneurial spirit and initiative. They must own or operate a business. - OUSC Technology Scholarship: Minimum GPA of 3.0 and be enrolled in a tech prep program.
- OUSC Military Order of the Purple Heart: Minimum 2.5 GPA; must be the child or grandchild of a Purple Heart recipient.
- OUSC Spriggs Family Scholarship: Minimum 3.0 GPA; parent must have been employed full-time for at least one year as a Lawrence County law enforcement officer or fireman.
- OUSC Dingus Family Scholarship: Minimum 3.0 GPA; be the first member of immediate family to go to college.
- OUSC Greg Smith Scholarship: Minimum 2.5 GPA; taking classes at the OU Proctorville Center.
- **OUSC Disabled American Veterans Scholarship:** Minimum 3.0 GPA; have a disabled veteran in the family, submit the 2020-2021 FAFSA by Feb 15, write essay on the "Importance of the Military to the USA".
- OUSC Evans Family Scholarship: Minimum 3.0 GPA; be the first member of immediate family to go to college, write 300-500 word essay on "Why I want to go to college."
- OUSC Myrtle E. and Lloyd Wood Scholarship: Must major in Education.
- OUSC Frank McCown Veterans Memorial Scholarship: Minimum 2.5 GPA; be the dependent of a veteran; Write an essay on "What Freedom Means To Me."
- OUSC India Association Scholarship: Minimum 2.75 GPA; Complete a 300-500 word essay on "Indian Culture and Philosophy."

<u>National Co-op Scholarship Program:</u> Application deadlines for each institution are different including some with 2021 early applicant deadlines. To qualify, students must have a cumulative GPA of 3.5 or better, complete all required admissions applications material and be accepted at one of the 11 National Commission Partner Institutions listed on the website.
